Since this arrest featured above there have been countless other arrests both against the western consumers of monkey torture, and the southeast Asian producers. Special mention goes to the arrest of Black Pearl which was as a result of the actions of a poster from this very same thread.

Part One: What The Fuck?

Without question, the most evil thing I have ever personally encountered online, is Million Pity. Stumbling upon it one night, my skin crawled, and some deeply primal part within me recoiled in ghastly fear at what I was seeing. Behold, the very depths of human cruelty. I'll warn you now, this thread deals with extremely distressing topics of animal abuse; if you are upset, please turn away.

What I am talking about is the phenomenon that exists on YouTube and elsewhere, of videos that began being created and posted in the 2010s – by some accounts the summer of 2016, by other accounts, years earlier – depicting the torture and abuse of (primarily) baby monkeys. Million Pity is as close as there is to an official name for it, based on an oftrepeated phrase that people in this 'community' throw around. In this thread, I will attempt to explain what is behind it; and no, it isn't just angry third worlders, like a lot of people seem to think. It's a lot worse than that, and a lot more complicated.

Nowadays this content is thankfully a bit harder to find on YouTube than it was some years ago, in say 2017, but it's still there and in large numbers. Threads about hating baby monkeys also frequently pop up on the 4chan animal board, /an/, too. There is a good chance you too, my dear reader, have encountered this in your travels. The question on most everyone's minds, is what the fuck is going on here?

To answer this, let me rewind, and properly explain what this is, and why it is so horrifying. Then we shall get into the who and why of it all.

For me, I first noticed it one night in 2019, or 2018. I was watching animal videos on YouTube; top 10 Orangutan funny moments, Scariest bug REAL, lizard with face of man found in brazil... that kind of thing. You know how it is. As it turns out, this was a bad idea. Somewhere along the way I encountered a video with a curious title in broken English and a morbid thumbnail of a young rhesus macaque in clear distress. I did not click on it, but as I continued to watch other videos, such thumbnails popped up on the sidebar with increasing frequency. What the fuck? I asked myself, and eventually I suppose I must've clicked on

Beyond what I was seeing in the video – I think it was a small monkey trapped in something akin to a stockade – which was freakish enough on its own, what really got to me was the comments.

Absolutely unhinged, frothing, and gleeful hate for monkeys, being expressed in the most batshit of terms. Seeing hundreds and hundreds of comments like this really freaked me out bats in or terms. Seeing fundated and intrinduces of comments the first early freaded the out in a way I had never experienced before. Clearly, there was something up here. I had stumbled upon a ghoulish crevice of the internet, wherein some grim and malformed culture of grinning freaks derived sadistic ecstasies from the brutalization of innocent creatures. The idea that there was just a community of hundreds or thousands of people lurking out there in the dark, who got their kicks from something like this creeped me the fuck out. Just what the hell is truly out there?

The thing that really got to me was the similarity of some of the comments; it wasn't just a disparate group of monkey haters, no, they all tended to use similar vocabulary – a jargon, if you will – and from the way they interacted with one another, and discussed other monkey videos they'd seen, it was clear that this was something far more socially developed than several unconnected people all commenting on the same video. This was a subculture of zoosadists rearing their head out in the open. I was reminded of seeing a crocodile submerged in a river; only its snout is visible, yet my nerves are set alight in fear, because I know something terribly dangerous lurks right under the surface.

So, what the fuck is this all about? Let's get to it.

Part Two: Paranormal Investigation

My interest in learning more about these strange, and terrible people was immediately piqued. But I found few answers amidst the rubble of internet hypothesizations. Answers do exist, however, and the place I found them happened to be the same place where you can learn how to summon a succubus, badly discuss Advaita philosophy, or ask God himself what his favourite anime is.

/x/ - Paranormal.

After a lot of searching, and lots of dead ends, I finally found the answers I'm looking for, and proof that the whole million pity shit was the work of a network of a group of dedicated zoosadists

There have been threads on the farms about this, none ever scratched the surface; in fact, the very existence of a monkey torture community was seen as being unlikely. Unfortunately, such a community exists. I shall now attempt to detail the workings of the monkey hate community over the past few years, from 2019 through to today.

Our story begins here, with this thread (archive) on /x/, which details (as far as I can find) the this person being Mr. Ape is from anonymous million pity posters:

first concrete evidence of the inner workings of the monkey hate community, via screenshots I know beyond all doubt lol. of a discord server named 'boysclub'.

This is not to say that this is the start of the monkey hate community; I've seen posts that imply it existed for many years before this, but I've not been able to find anything solid yet. As best as I can gather, the community may have sprung up around 2014/15 or thereabouts, centred around massive YouTube playlists; when the playlists and videos started getting nuked, the community moved to "MT Forums" (Million Tears, presumably) in 2016 through to 2018. I have heard conflicting info on whether this was the first consolidated gathering of the community or not.

Anyway, flash forward back to 2019, and boysclub. I've attached the screenshots provided by anon; all the censorship of images and names was done by the original poster, so unfortunately no names of the people involved came out of it, but at least these screenshots do not contain anything too graphic.

This discord was discovered in 2019 unfortunately, which means that it's almost certainly dead now. One thing that is known however, is the fact that the leader of this discord was someone named Poyo Zo, but I've not been able to find out much more than that. I'm not any good at doxing unfortunately, so if any investigative minded kiwis fancy digging into a zoosadist, that's a name to start with.

The discords were only the start of it, however. From this point it gets a lot worse, and a lot more sophisticated. I'm not sure what the community was up to in 2020, but in 2021 they came to widespread prominence. As detailed in these articles (all archive links), there was a major exposé regarding the monkey torture community in that year.

Here's the skinny: In May of 2021 (probably a lot earlier, too) people used YouTube videos, like the ones described above, to recruit members into private telegram groups (essentially the same modus operandi as Poyo Zo and boysclub).

In these groups, not only were monkey gore videos shared between users, but the members decided to take it one step further and start producing their own videos of monkey mutilation. A selaborated above, the million-pity thing is a lot more complicated than that. The decided to take it one step further and start producing their own videos of monkey mutilation. Commenters on the YouTube videos, the members of the telegram groups, the anons on Ochan: none of them have been third worlders, they have overwhelmingly been Americans, or at least from the Anglosphere. It's similar to the production of CP in Southeast Asia, à la A scheme to 'adopt money's made a money to pay people in Indonesia (referred to as VO's, statium points).

Some of the richest members of the groups had their own personal monkey, others would share a monkey, in the single most fucked up kind of carpooling I have ever heard of. The members of the group were predominantly from America, but some were from the UK. Below Firstly, the country where almost all the YouTube content comes from: Cambodia. The Cambodian videos are – broadly speaking – of two types; pet monkeys being mistreated by their owners, and "animal rescue" videos.

After the publication of these articles, Telegram and other forum hosts that this group was hosted on shut down the groups, and... that's it? No one was arrested that I can find, no one faced any kind of justice, despite their crimes being brought to light. It came so close to this entire thing being brought mainstream attention, like the Furry Zoosadists from a few years ago, but instead, it was forgotten after Telegram shut down the group. But this doesn't mean that the problem went away. The distributors retained their contacts to the clients out west, and the monkey torture porn was still produced unabated.

This brings us to January of 2022, and to the website Ochan.life. From here on out, assume all links to potentially contain NSFL material. This obscure forum became the new hub for monkey hate, and one particular person rose to prominence: Mr. Ape (dox below) mp17.png

In this thread (a (other archive) Mr. Ape essentially tries to become the million pity main character. He and the users of 0chan created a new telegram link for the collation and creation of monkey torture, and began recruiting new members from 4chan and elsewhere as mentioned earlier, boards like /an/ and /gif/ became prime hotbeds of ape hate radicalization; the Darul Uloom Haqqania of animal abuse.

Under Mr. Ape, he and his recruits (they unironically called themselves his 'chimps') contacted one of the members of the telegram channels from the 2021, who would then

contact various Indonesian zoosadists-for-hire, and produce snuff films featuring upwards of twelve monkeys who were killed for the pleasure of the 0chan creeps. A big part of why Mr. Ape's group was a step up from what came before, is that besides commissioning many, many videos of animal torture, they would freely distribute them on 0chan, to attract more and more monkeyfucking freaks.

A big thing I have noticed about million pity posters, is the fact that in addition to being coosadists, they are the single most insufferable group I have ever encountered. They have all the delusional narcissism and undeserved victim complexes of furries, calling people who oppose them 'Karens', as if the idea that people shouldn't torture monkeys is something only on writing about some of the more notorious Indonesian producers of monkey snuff. To quote from him:

"Here's the information I have on the two biggest and most notorious monkey torture video and the packground setting."

As befitting a bunch of limp dick attention whores, whose only discernible personality traits are edginess and a supply of mommy and daddy's hard-earned cash, drama swiftly erupted, and Mr. Ape was doxed – not by any animal activist or anything like that, but by one of his own minions over some petty monkeyfucker drama. It evidently wasn't that hard a task, as Mr. Ape not only never stopped bragging about his area of study, but also gave out his phone number on telegram, as well as falling for numerous scams and cons. He apparently had serious delusions of grandeur, not only about his STEM degree, but also as being a perceived 'king' of the monkey community.

As best as I can tell, Drexel was doxed by one of his own 'friends', who either did it because they felt like they were not getting enough clout for their role in producing the videos, or perhaps they hated Ape, or whatever.

After Drexel's doxing – which seems to have occurred quite recently as of my writing, though I couldn't tell you an exact date – the community imploded in a frenzy of paranoia regarding who'd be doxed next by the "Karens", who to trust, and so on. The community on Ochan can be seen currently in a state of cannibalization, as users turn on each other, pointing fingers, hurling slurs; rats flee the sinking ship. In the midst of all this, monkey videos are still being spread on there, but to a much lesser degree than when Ape was active. Currently, it seems like the users of that forum are not in consensus of what the next step the community at large shall take is; users want a new telegram group to replace the Ape one. I am not sure if it has already been created, but either way, it is certain that this won't be the end of it. There will be splinter groups, there will be new websites, just because this thread has been written at a time of stagnation for the million pity community, does not mean that the scum has been washed away. There is still a demand for torture porn, and there are still distributors. Mr. Ape was just a symptom of this the psychotic zoosadism disease. There will be another. More innocent animals will die. It overwhelms me with disgust and sadness to think about. I shall now talk about the people behind the camera: the VO's, who film the torture.

Part Three: Insane Asians

When I began my research into million pity, one of the most common theories behind the phenomenon was that all the commentors on YouTube were a bunch of angry third worlders; this opinion is so ubiquitous that it was even parroted here, on this forum. mp25.png mp26.png mp27.png

As best as I can tell, they mainly come from one of two countries, with both countries tending

A majority of the content on YouTube is a result of this. Some monkeys develop rabid cult-

followings, akin to pornstars – it's a disgusting comparison, I'm sorry, but that's really how it is – and you'll often see YouTube users talking about specific videos or monkeys. Secondly, and far worse, are the Indonesian producers of monkey torture content. The Cambodian videos may be considered 'softcore', but it is Indonesia where the bulk of the truly horrible stuff is created. While I was researching for this thread, I found an excellent (and very recent) writeup someone did on reddit (archive) (he claims to be currently

producers. It's very easy to tell which producer is which based on the background setting and style of videos they produce. Both of them live in Indonesia, but that's all I know about

They always torture one specific species of monkey called the crab eating macaque, also known as the long tail macaque. They are native to large parts of South East Asia and are very commonly found in Indonesia in particular. Long tail macaques are not an endangered species and are often considered pests by locals. Up until a couple years ago their conservation status was categorized as least concern, though nowadays they are considered threatened. As far as I'm aware there are no regulations on their sale in Indonesia. As such, baby long tail macaques can often be found in Indonesian pet markets First I'll describe the most notorious of the two most popular torture video producers and also the most well known. This is the person who ran the Telegram server that made it into

mainstream news articles last year. Before producing that type of content he was a typical

a reliable audience of monkey sadists. He is most commonly known as Ji Owner within the monkey hate community since he was famous for owning a heavily traumatized baby monkey named Ji that he exploited for views on his old Youtube channel. Ji herself was famous for constantly holding the back of her head with her hands and rocking back and forth due to a traumatic upbringing. Somehow the monkey sadists found that hilarious and now Ji is something of a mascot to them. You can find out a lot about that by typing "Monkey Jü" into the Youtube search bar, there are a ton of videos documenting the abuse this man has wrought against baby monkeys while he was still just a Youtuber a few years ago. Once Youtube banned him he became a full time monkey snuff video producer. Note: new videos of Ji are still being uploaded to Youtube, but the channel that does this claims to be a new owner and not the original Ji Owner. I don't know whether or not that's true.

That channel was banned by Youtube in late 2021, but he keeps popping up under new names, moving from channel to channel as Youtube plays an extended game of whack-a-mole with him. He doesn't upload torture directly to Youtube, but The beat the state of the state extended game of whack-a-mole with him. He doesn't upload torfure directly to Youtube, but the does mistreat them in his Youtube videos. That consistently leads to his channels getting the banned. The purpose of those channels, as far as I can tell, is to advertise to monkey sadists who then contact him elsewhere to buy custom videos. You can tell which channels are his by the distinct layout of his property and an assortment of recognizable cages that he keeps his monkeys in. Sometimes you can even recognize the monkeys that appear in his Youtube videos as monkeys tortured in his privately sold torture monkeys that appear in his Youtube videos as monkeys tortured in his privately sold torture videos. You can tell apart his torture videos from those of Ji Owner by the higher quality of video and the fact that he usually works alone. That's not always the case though, occasionally he has someone else helping him. Also more of his videos tend to be indoors as compared to Ji Owner. He doesn't seem to own a tripod and has a tendency to hold the camera between his legs in a squatting position while he uses his hands to torture monkeys. Instead of nailing or trying them to trees like Ji Owner does, he has a tendency to tie them up spread eagle to the outside of their cages.

This is all I've been able to find; info is quite scarce online, and unlike this redditor, I refuse to try and infiltrate any monkey groups. Researching this thread has made me upset enough as is. Debugging Code Found in Human DNA

The Strogg are a hostile cybernetic alien race featured as the main antagonists in Quake II and Quake 4, and as a playable faction in Quake III: Team Arena and Enemy Territory: Quake Wars. Members of the Strogg race also appear as playable characters in Quake III Arena, Quake Live, and Quake Champions. The Strogg are cybernetic constructs of unclear origin, which reproduce by taking biological components and fusing them with advanced technology in the brutal surgical process of Stroggification that enslaves their minds and enhances their bodies for war.

The Strogg's need to harvest biological components for their own augmentation, and the flesh of slain enemies for the creation of stroyent, is their primary motivation, since it's necessary for their survival. This motivation led the Strogg to Earth, which they promptly invaded, slaughtering millions of humans just to harvest their corpses. This Strogg aggression led to humanity's long war with them that has continued unabated ever since. Among the SMC, Strogg are referred to as squibs.[1]

Background

Origins

Not much is known about the origins of the Strogg. They appear to be a humanoid race that originated on Stroggos, which has developed much like humanity. At one point, Strogg society became subordinated to powerful leaders, not unlike humanity's various dictators throughout its history. Unlike humanity, the Strogg continued to iterate on the system for several centuries, eventually hitting a threshold where war, conquest, and destruction began to dominate their ideology, becoming their sole reason for existence.[2] Rotting remains of this ancient civilization would become the foundation for the grand palaces of Strogg imperial conquerors, long lost to history - but still eerily reminiscent of Earth's darkest hour, dominated by Orwellian forces.[3]

Eventually, the Strogg expanded among the stars, with Stroggos becoming the heart of their civilization. Although suffering from industrial development and reduced to a barren wasteland, [4] Stroggos and its capital city of Cerberon would persist as the heart of the cybernetic war machine[5] for hundreds of years. The ancient Palace complex, consistently updated with the latest in Strogg technology, would remain the seat of the Strogg Makron, the highest ranking leader responsible for directing its imperialist policies.[2]

These policies would remain focused, if not fixated, on one policy: The aquisition of new organic material for fueling their war machine, twisted and ruined by centuries of war.[6] Stroggos was reduced to a wasteland, with factories and refineries spewing pollution and toxins into the environment for decades, if not centuries. What remained of Stroggos wildlife adapted, becoming fierce, carnivorous beasts preying on whatever organic material available.[7]

First contact

Humanity's first contact with the Strogg appeared during the Slipgate experiments under Dr Wendell Gilman. The scientist made contact with the strogg during his experiments, and used the technology gained from the cybernetic race to improve human Slipgate technology The result was stronger, improved Slipgates that allowed human researchers to establish and maintain portals between their dimension and the "other side". An unforeseen result of this decision was the revelation of human space to the Strogg, paving the way for the War against the Strogg that began with the Strogg invasion of human space (which may very well be a response to what they interpreted as "human provocation" or Ranger's one man extermination of Shub-Niggurath).[8]

The brutal Strogg invasion occurred in 2065,[9] after sweeping through outlying colonial holdings on Mars and destroying human orbital facilities like the McCulloch[10] and Armstrong space stations,[11] which were long the subject of speculation. In fact, the Strogg may have created their nemesis during the invasion, as Corporal Matthew Kane served on Armstrong, and was hospitalized during the battle for Earth.[12] The Strogg made a fatal mistake: They attacked humanity. While other species yielded to their superior technology, such as the Psi-Radar,[13] Rail Howitzer,[14] Plasma Mortar,[15] or the Dark Matter cannon employing Bosonic orbs,[16] humans steadfastly opposed them, fighting tooth and nail for their survival. The newly formed Global Defense Force or GDF seized on any opportunity to counter the Strogg, including the capture of Strogg Slipgates to uncover the enemy's secrets,[17] aggressive researching and reverse engineering of Strogg biotechnology,[18] and capture of vital Strogg assets like DataBrains used to construct Strogg facilities on Earth.[19]

The GDF exploited a small, but significant flaw in Strogg battleplans: The cybernetic race o conquerors decentralized its operations, constructing ad hoc stroggification facilities on conquered planets, with little regard for the strategic situation. [20] Although not significant their own, coupled with the survival of human observatories that recorded the first appearance of Strogg slipgates used to invade human space,[21] and Strogg attempts to convert existing hydrocarbon extraction infrastructure for stroyent production, [22] allowed the GDF to gather enough intel and material to reverse-engineer Strogg technology and orchestrate a counter-strike.[23] In fact, the desperate fight against the Strogg invasion of Earth provided the first clues to the existence of a Strogg Nexus, [24] the sophistication of their technology when Contaminator devices were deployed to try and change humans into A sample of Strogg-style script used for the "English" signs on Stroggos in Quake II: zombies en masse, [25] and the vulnerability of Strogg technologies to electromagnetic pulse "WARƏHOUSƏ".

Counter-attack by humans

The Strogg likely did not expect fierce resistance by mankind - or the reverse-engineering of their technology. The Terran Coalition of Man focused efforts on finding a permanent solution their technology. The Terran Coalition of Man focused efforts on finding a permanent solution to the invasion, as the GDF battled the Strogg across Earth. Soon, they discovered the origins of the slipgates, a sophisticated use of black holes to propel Strogg invasion forces across the vastness of space, and the Space Marine Corps was tasked with organizing a counter-invasion. Even as Earthen cities (or rather, their ruins) still smoldered, SMC Marines boarded C-30K troop carriers to lead an invasion of Stroggos, using sophisticated Mark 9A drop pods and reverse-engineered Strogg war tech.[27]

Stroggos, a desert wasteland, witnessing the second human invasion

Stroggos became the target, rather than the perpetrator of a military campaign for the first time in centuries, as the SMC focused on the core of Strogg civilation, the planet of Stroggos and its capital city of Cerberon.[5] After Bitterman, Joker, and Stepchild managed to achieve the SMC's operational goals, despite the Corps suffering an unprecedented 95% casualty rate that left just 5% of the Marine force operational, the Strogg were put on a defensive footing, paving the way for a mass ground invasion by the SMC. Unable to repulse the attacks, the Strogg attempted to compensate by a brutal conversion of Marines into stroyent and various cybernetic monstrostities. However, even the deployment of Tactical Strogg, utilizing the best of the best of SMC troops to produce an answer to humanity's own soldiers was not enought to hold the line: Humans adapted faster than the Strogg could. This was best exemplified by the deployment of Corporal Matthew Kane, himself a Tactical Strogg who nearly finished conversion, to penetrate Strogg defenses and attack the Nexus itself.

Organization

The Strogg are bionic constructs with mechanical and organic parts fused together, with most controlled by a remote command and control system. Few are individuals in the usual sense

The Strogg have settled on a centralized system of command and control, organized through a system of warlords. Each of these prominent Strogg would be responsible for a specific strategic location or aspect of the civilization's operations, and all would answer to a Makron, elected from among the warlords to command the Strogg civilization from within the ancient Palace located at the northern end of Cerberon. This system granted a degree of efficiency, but also rendered the Strogg vulnerable: The assassination of the Makron would leave the Strogg confused and battling internally for succession, a fact that the SMC exploited to the fullest possible extent - despite the uncharacteristicly swift election of a successor after Bitterman's successful attack.[29]

Culture

Many such banners still hang on or inside Strogg installations, though many of them, like the buildings, are weathered, torn, stained, and almost ancient in appearance. It's possible the Strogg still make these flags and display them as a holdover from a past age when they were less enslaved by their technology, since otherwise they would see this as a waste of resources due to their lack of need for morale or military pride compared to humans.

Strogg society is marked by brutality and savagery without parallel. The biggest and strongest Strogg are automatically the ones with higher authority. The most superior Strogg gain the title of Makron and have absolute power over the Strogg civilization or society. Larger and more powerful Strogg have little respect for their weaker brethren, with many a light tank killing or trampling lesser Strogg foot-soldiers if they get in the way. Unique powerful Strogg function as guardians and act as subordinates to the Makron, such as the Tower Guardian which was tasked with the outer defense of the three security stations surrounding the central Strogg Nexus tower.

The precise reasons for invading Earth beyond resource harvesting were never identified. Beyond retaliation or responsind to Gilman's slipgate experiments, SMC Marines speculated that the cause was simply because of Earth's strategic location, giving the Strogg the ability to attack dozens of other civilizations,[30] following a long-forgotten directive from an ancient war in another part of the Milky Way galaxy, due to them being created as super-soldiers for overcoming enemies,[31] or simply following the logic of evolution: The Strogg marriage of flesh and tech was the next step in the advancement of species.[32]

Strogg culture - or what remains of it after centuries of constant war, expansion, and elimination of independent thought - is dominated by a fixation on warfare, with all their efforts being geared towards this single purpose. The majority of buildings on Stroggos are nothing more than countless armored bunkers, weapons factories, defenses, and massive fortifications. The Palace of Cerberon is a rare example for prestigious Strogg architecture. Many of the buildings show signs of extreme age and crude construction, rusting to the core though they all tend to have the same kinds of elevators and automatic doors that are typical of human military installations.

The Strogg language functions very similarly to English, with various symbols forming separate words and basically working as letters, as opposed to symbols representing whole Strogg gather corpses for processing, and capture live humans for stroggifications or meanings in the way that Chinese, for example, works. However, there is little indication that conversion into stroyent. Humans are specifically seen as either food or potential many humans have managed to understand it even after years of war against the Strogg and study of them. Understanding of the Strogg language is gained from a neurocyte being implanted in the cerebral cortex, and few human translators would volunteer for such a procedure.

Language remained a key barrier in fighting the Strogg. By the time the SMC invaded Stroggos, only eight humans were fluent in Strogg, and barely four understood Strogg programming.[33]

Technology

The Strogg mastered many aspects of science, thanks to their utter absence of ethics and emphasis on practical results. The Strogg have no concept of ethics in their medical conversion the research and will do anything to anything living that they get their hands on if they think it can indefinitely.[47] help them streamline the stroggification process (where alien species such as humans are subjected to a brutal surgical procedure where entire parts of their body are replaced by biomechanical implants), advance their own medical capabilities, or enhance their weapons to kill more efficiently.

The biomedical sciences, are a priority as a result. Those who aren't sent to be processed into Strogg are used for mortality tests. Various organs are removed by Strogg scientists without the use of any kind of anesthetic, to study the agony of their captives and the bodily response to various surgical interventions. They also want to ascertain how long a human can last without certain organs. To the captives, this procedure is torturous, long and horrific, driving the victims to insanity and inevitably death.

Humans captured during the Strogg invasion who weren't processed on location were removed to Stroggos, where they underwent "conversion": A traumatic procedure where entire parts of the body were removed using crude surgical implements and replaced with mechanical appendages. Subjects were kept alive by a combination of steroids and healing medicines.[34] Additionally, nanites were introduced into the body and continuously repaired Blaster, Machine Gun, Shotgun, Nailgun, Grenades Lightning Weaponry, Rockets, Railgun, tissue, even in body parts that were entirely separated from the host.[35] By the end of the Dark Matter Gun, Incendiary tissue, even in body parts that were entirely separated from the host.[35] By the end of the Dark Matter Gui process, less than half of the original body was left, with human doctors describing the whole # Strogg units process as sophisticated mutilation.[36]

At the same time, Strogg technology was incredibly sophisticated, bonding with existing nervous systems on a level deep enough that even the most advanced medical systems at the SMC's disposal would be hard pressed to disentangle them.[37] This level of bonding was necessary, as all command and control was centralized in the Nexus, with most Strogg completely enslaved by the neurocyte implanted in them as the final stage of the stroggification process. A transceiver located at the base of the skull provided the connection to the Nexus, dictating a Strogg's every move, overriding their higher thought processes. This reliance on external processing led to a general atrophy of independent thought among victims of stroggification, although most of them retained awareness of their actions for a short time after the procedure, until the higher brain functions atrophied.[38] The mere presence of the neurocyte in a host grants them a command of Strogg language, the ability to intuitively access Strogg control panels and pass through security grids unhindered. Though small, each contains an artificial intelligence programmed into it that's responsible for these gains, interfacing with Strogg hardware implanted during the stroggification process and pre-existing nerve systems, such as the cerebral cortex (as onboard memory, equivalent to RAM), accessed by temporal implants wired directly into it.

Nexus

The Nexus was a vast communication system responsible for processing and coordinating these actions, capable of processing and organizing billions of Strogg in real time, delivering instant instructions to drones in the field, straight from the small number of Strogg leaders.

It's unknown how Strogg are subject to emotions after linking the neurocyte to the Nexus. The Makrons possessed an arrogant character, laughing grotesquely at their enemies in combat and taunting them, while various Strogg shout about detecting traitors or enemies upon sighting SMC troops.

Strovent

The biomechanical nature of the Strogg was bolstered by their use of the stroyent, a synthetic substance that provided both health and ammunition to cyborgs in the field.[42] It is distributed either as packs or fixed "health stations", where a biological storage unit is used to hold the stroyent, until it's needed by a Strogg cyborg for replenishing health and ammunition.[43]

Stroyent is generated by processing any organic material (including crude oil, as the GDF discovered during the invasion Earth) by the Stroyent Processing Creature or any on-site processing materials. The Strogg specifically gather the dead remains of their enemies

through a process known as harvesting. Both specialized Harvester walkers and individual conversions, in fact.[44]

A related development are the torso storage units: The Strogg were able to take power from human torsos and used many biological systems wired directly into their facilities, such as the giant heart which pumped stroyent across their world. They were able to power whole facilities using torsos, many of which were headless and regulated by a neural link that kept their body functions going. Others still had heads but showed signs of extreme intoxication. Alloys and other tech[]

The Strogg rely on the use of hardened tribinium for much of their technologies. Comparable to Marine body armor alloys, the Strogg metal is exceptionally difficult to work with.[45] Other notable achievements include the Icarus GravPac, granting even the least of the Strogg conversion the ability to make long-distance jumps,[46] and dedicated cyborgs to fly

Furthermore, Stroggos overwhelmingly relied on a local bluish crystal called steedium to generate power and maintain the many systems on Stroggos, up to and including its planetary defenses (the Big Gun).[48]

Other military technologies[]

In summary, the Strogg possessed superior technology to humans, at least at the outset of the war. Their most advanced technology is the use of black holes to travel massive distances (harnessed as slipgates), which also led to the development of teleporters. The teleporters are specially made only to transport Strogg and kill humans that use them, unless they have been stroggified, exhibiting Strogg physiology.

The Strogg have developed a variety of highly advanced weapons, ranging from small energy-based blasters to fully-functional railguns and even the Dark Matter Gun, a devastating weapon firing a deadly orb that consumes smaller enemies and inflicts severe damage on bigger ones. In the following, there's a short overview of common Strogg weapons

The Strogg use a variety of different cybernetic constructs as soldiers. Here are some of the different kinds of combat units:

Aggressor, Constructor, Infiltrator, Oppressor, Technician, Arachnid, Berserker, Brains, ... # Non-military Strogg

There are Strogg that are not used for military purposes. These Strogg primarily specialize in medicine, engineering, or science: Brains, Medic, Technician, Scientist, Repair Bot.

Behind the scenes

The actual background for the Strogg was never detailed, until Quake Champions developer SyncError noted in the official Discord server's #lore Channel that Ranger era was likely the first contact between humanity and the Strogg. More precisely, according to Strogg and Peeker lore scroll 5, most of enemy units in Quake II are strogified Greiss, the same one the Scalebearer hails from. The Strogg May have even had contact with humans before the events of Quake and Quake II. It is believed that the Strogg are a creation of The Great Old Ones, as a method to exterminate mankind after the death of Shub-Niggurath, with creatures such as Armagon and the Centroid being possible prototypes of the Strogg race.

Another real-world equivalent to the Strogg script in Quake 4 for English-speakers would be for a post 90s born Croat to try to read Serbian Cyrillic. Along those lines, "strog" happens to be a Croatian, Serbian, Slovenian, and Bulgarian word meaning "strict" or "harsh' In Ancient Greek orthography, to represent the velar nasal, "ng" sound, the digraph "gg" was used. Therefore, when applying this logic in reverse to "Strogg" you reach the English word "Strong". Though this may be a mere coincidence, it should be noted that the term "Makron"

The Strogg also have many similarities to the Borg Collective from the Star Trek universe in the same manner they procreate; the only difference is that the Strogg lack any signs of hard interdependency.

I am a Private Investigator, working in the North East. I work for a national firm, dealing mostly in Worker's Compensation and other Insurance claims.

I'll try to answer all questions the best I can, at least through the end of the day. Edit: Verified

GreatCanuk69: How do you investigate things? Do you use gadgets?

OP: A typical Investigation starts with a background check. We receive an automated database check for each case which provides us with all recent addresses, phone numbers relatives, criminal history, vehicles, professional licenses, etc. After reviewing this, I delve deeper, looking for social networking profiles and other webpages that mention you. Even if you don't have a facebook, there is a good chance that one of your relatives or roommates

do, and a good chance that they have pictures of you or information about you online. The very best situation is one where I find an e-mail address. A google search of someones e-I have done one of these before and these pop up a couple times a year, but there seems to mail pulls up an incredible amount of information, basically every site you ever used it to

> After all that, a typical case requires 2-3 days of surveillance. I park inconspicuously in the neighborhood, either within view of the residence (best case) or watching the most likely route that the person would take to leave. From there, I'd follow the person every where they go, usually in 8 hour shifts, and document their every activity.

> For equipment, I have a 70x zoom digital video camera, an awesome little twisty tripod that can attach to just about anything, and a covert camera that looks like a button to use if I follow people inside a building.

Started early, and right properly. They also tend to post less.

metalbum14: How do you manage to get around the privacy settings that might be set up on social networks? Or is it not worth it to bother?

OP: There is no legal way around the privacy settings. I know of some Investigators with private companies who will using phishing, or create false profiles to friend people on facebook, but those practices are illegal, and an easy way to lose your license if your caught That being said, about 50% of the time, if the person has a completely hidden facebook, I can still get pictures of them and information about them through other people's profiles who are not as careful with their information. I usually get a list of relatives and neighbors for every case. If the person is a parent to a highschooler, I can almost guarantee that I'll find a "Family" album on their child's profile, or something similar.

CrisisOfConsonant10: As a person who has no social media and actively avoids pictures, has no friends, and doesn't really do anything I'm your worst nightmare. I also use different user names on pretty much all the websites I register on.

Well I would be except I don't do anything interesting enough to warrant being investigated. Why do you think 24-40 is so careful about privacy? I've been on the internet for a long time, I realize the permanence of it, but I feel there are plenty of 30 year olds who don't (they're not probably provided your cousins wife with sufficient hard evidence as well, pictures, video, generally as active on social media as 18-24 but that's because they weren't raised on it).

OP: I only find social profiles about 50% of the time. A surprisingly large number of people don't maintain an online presence at all.

dog_in_the_vent17: I park inconspicuously in the neighborhood

How often to people come up to find out what you're doing?

OP: I stay far enough away from my claimant's residence where they won't have any idea that I am there, my camera's zoom is strong enough to read a newspaper from 150 feet away. That being said, I usually am sitting directly outside of someones house for 8 hours at a time. I don't always get asked questions, but I probably get approached a few times a week. I'm good at lying though, and people tend to trust me.

dog_in_the_vent18: That being said, I usually am sitting directly outside of someones

house for 8 hours at a time.

That's more what I was worried about. I'd certainly be curious about a stranger who was parked on the curb outside my house.

What do you tell people when they ask what you're doing?

OP: Usually I tell them that I'm doing a vehicle repossession. If they inquire further I just tell them that I could lose my license for disclosing any further information, and they typically accept it. The trick is sound extremely professional when they first approach you, and then bitch about your job/boss giving you pointless dead end files. If you complain about your pretend job, people automatically believe you.

billylooser16: If I would run into someone observing a residence from his car how do I know it's a private investigator and not a burglar?

OP: Call the police. If they are a private investigator, the police will know that they are there, and will assure you that they can remain there. If they are not a private investigator, the police will want to know that they are there. Win win really.

If even that isn't possible, I'll probably ask a neighbor who is far down the road to park in their driveway. Most people oblige. There's nothing neighbors or police can do to force me to leave, as I am exempt from loitering laws as a PI

benwaaaaaaaah8: So I just Googled my email address and nothing came up related to me Also, my FB first and last name are completely different than my real life name. What would you do in that case?

OP: Not everyone keeps a strong online presence. Some people that I investigate don't ever own a device that can go online. I would just discount the social networking check, and continue normally. I'd still know all the basic info from our back ground checking program: vehicles, addresses, relatives, etc. You might be careful with your facebook, but are other people careful with it? Does anyone list you as a relative or as in a relationship? Do they have photos of you on their facebook pages? If I can't find a profile, I'll typically look through their relatives, find someone whos between 15 and 20 years old, and look up their facebook page. They will undoubtably have one, and will probably not care for their own or anyone

And to determine your willingness for AMA, how best can we make things tricky for you?:) OP: Get a lawyer. Unrepresented claimant's are way easier to investigate. When they aren't represented I can actually approach the residence, talk to them under cover, call their house to confirm them home, things like that. They also tend to be less on the look out, and less attentive to online privacy.

OP: The insurance companies usually are the ones hiring us. They pay for it because they have anywhere from a couple tens of thousands to over a million dollars at stake.

manskies35: My cousin had a private investigator on him because his wife suspected him of cheating on her. I highly doubt he would do something like that. The P.I. told his wife he was seeing his secretary. Could it be possible the P.I. was lying to his wife so he could get paid?

OP: It's unlikely. The PI would get paid either way, so he probably doesn't really care about the outcome that much. Things are never as simple as they seem though. I don't deal with infidelity at all, but there are laws prohibiting videoing people where they expect privacy and what not. The PI couldn't know exactly what he was doing with the secretary, unless they were doing it openly in public, only that he visited the secretary outside of work, etc. The PI audio. etc

artosis42031: What are some tell tale signs that I am being investigated? Apart from someone losing their limp, what type of evidence can you use to prove insurance fraud? OP: The best way to know if you are being investigated is to just keep an eye out for cars that you see often. We tend to be pretty good at not being noticed, but if someone is really watching for it they will notice that they keep seeing the same little black honda over and over where ever they go. It will never be obvious, I usually stay a couple cars back when following people, and I try to stay as far from the residence as I can while still being in view of

Most cases aren't as cut and dry as someone completely faking an injury. A lot of times it will be a legitimate injury that they are exaggerating, or an legit comp claim that they had, but have since healed and don't want to lose their compensation. Most claims come with restrictions, ie: don't lift more than 10 pounds, no bending at the waist, etc. Most of the evidence is centered around the restrictions.

SomeFokkerTookMyName32: If GTA taught me anything, it's that staying two car-lengths back will make you invisible.

OP: It's basically true. I hate the stake out missions on GTA, totally inaccurate, and I feel like I'm just repeating myself.

kayleighswift15: How do you/would you handle motorbikes? I imagine it would be hard for anyone in a car to follow me to work, with the amount of overtaking and lane splitting I do. vOP: I hate motorcycles. On top of them lane splitting, they tend to accelerate far faster than I can, and are extra attentive about the vehicles around them. I have followed them

successfully in the past, but its a pain.

familyorfriends10: You make a workers comp or personal injury claim and the defense is contesting the extent of your injuries.

OP: Pretty much. It's rare to find someone who is completely faking it. When they do, they usually use phycological claims, which are difficult to prove false.

family or friends 16: I have a question. I live with a person with an "invisible" disability. Sometimes they are able to do things they normally say they can't, like walk without a cane for a period of time, carry a bag, etc. But what normally happens is that they will pay for it later with pain levels.

How often do you use things like that for the benefit of your clients? Do you use little brief moments like that to provide evidence someone is not disabled or as hurt as they claim?

OP: The "good day, bad day" claim is pretty common. Just because someone bends over to pick up a quarter off their driveway doesn't mean that they don't have a bad back. To combat this, we typically work consecutive days of surveillance and try to show that the person repeatedly breaks their restrictions without any sign of pain or discomfort at the time or later. Sometimes it's obvious though, a claimant will tell their doctor that they can't even move their right arm without extreme pain, and then we get video of them lobbing furniture and trash bags into a dumpster with said arm.

Some clients will try to use individual instances of breaking restrictions to reduce the amount of money being paid out, but if the claimant is represented, they aren't usually successful. familyorfriends5: By the time they call you in, are your clients fairly convinced that someone is outright lying about or exaggerating their injuries?

Are your clients defense attorneys, insurance companies, or the third party workers comp administrators?

Edit: what stage are you brought in? Do they use your info to deny/approve someone's claim? Or do they use it to support the denial after the fact?

OP: Hiring a 3rd party investigation firm is fairly expensive, so they usually only call us in when they are confident in their suspicions, usually after an anonymous tip.

I've had all 3 as clients, usually it's insurance companies though.

We are typically brought in to either reduce the claim, or deny it outright after they've already been receiving compensation. If we are brought in before compensation is given, it is usually to conduct statements and scene diagrams.

FlamingEagles23: have you ever been "caught" by someone you were investigating? what happened? how much money does one typically make in your line of work?

OP: It isn't unusual to get made on cases. If someone is committing fraud, they typically have heightened suspicion and will be looking out for us, especially if they aren't new at it. The worst one was on my first week of work, inexperienced as I was, I sat too close to the residence, and the person saw me with my camera. Usually people will just give you a horrified look, or flip you off, but this guy decided to get in his truck and chase me down. Luckily for me, my car is quite speedy, and I was able to shake him pretty quickly. We walk a pretty thin line between legal stalking and harassment. If a claimant makes it known that they know of our presence, we have to leave immediately or else it becomes harassment Money is tricky, as there are a lot of non-taxable incomes and reimbursements. Typically I can count on around 45k a year after taxes, but I've only been at it for 2 years or so.

Tyster40720: What was the weirdest thing you came across in a case?

OP: Trees. Through some digging online I found one of my claimants purchased 500 apple trees. They lived in a condominium. I never found out what that was about.

NeedWittyUsername16: Maybe they just really liked apples.

OP: I suspect it may have been an illegal transaction, but that's really none of my business. blake1289s19: So I'm getting ready to graduate high school, and I am seriously looking into becoming a PI but I have no idea how. So I have a lot of questions. What do you major in college? How do you find work after college? Can you leave the states and work in a different country with your degree? What is the average pay, and is it an exciting job? Lastly, "formalities" and I learned to always let the police know I'm working in the area. And no, no are there more requirements than a college degree?

OP: I majored in Criminal Justice in college, graduating Magna Cum with a Bachelors of Science. I got this position about 2 months after graduating, after seeing it on Indeed.com. I simply applied through the site, and got an interview shortly after. The hiring process is lengthy, as they need to do a lot of background checking to make sure your not a crazy person. It took about a month from my first interview to my first day of training.

work in another state, it would just be a matter of filling out the paperwork and paying the fee. Your experience and college degree should count if you decided to leave the country, but I am not familiar with PI laws outside of the US.

Pay tends to be complicated, as there are a lot of non-revenue reimbursements (untaxable) that amount to profit. A typical year will be around 45k after taxes with reimbursements, and then I can expect a sizable tax return, probably around 5K - 7K for other expenses I incur throughout the year (Feds pay 65 cents on the mile for vehicle depreciation, etc)

It is a very exciting job, but it isn't for every one. I'd suggest finding someone to do a ride along or two with before you take a job. 80% of the job is spent sitting in a parked car, waiting for someone to leave their house. You might spend 10 hours staring at a front door waiting for someone to leave their nouse. You might spend 10 hours staring at a front door, just to get 10 seconds of video when the person comes outside to get the mail. Or even worse, you might spend that time staring at a house and get no activity at all. That being said, when there is activity, it is very exciting, fast paced, and high adrenaline work. In my opinion, all the waiting is worth it, and I thoroughly enjoy the job. You have to be ok with lying christcht: If you have license plates, how do you go about digging into a vehicle history? to people every day (neighbors can't know that your investigating someone, and they will ask you why you are in the neighborhood), you need to be ok with writing reports, and breaking driving laws. No company will ever say to you "break the law", but your clients will be upset if and the address of the registrant.

No other requirements but that, PI laws vary state to state, but you can get around them usually by getting licensed through a company. Not even a college degree is required to have the license, but most companies require a Bachelors in something vaguely related. OP: I've only gotten one speeding ticket since I started, and have a pending tint violation. I have a high end radar detector that mostly prevents tickets. The company officially states that it does not approve of breaking laws. That being said someone would be pissed if I lost someone due to my not speeding or running a red light. Due to that official statement though, I am responsible for any fine I incur. It comes down to risk evaluation.

Dayanx2: Never having seen Breaking Bad, Im writing a short story about someone in your line of work, have you read any good fiction that puts a realistic edge to modern PI?

OP: Unfortunately, no. Realistic pi work doesn't make for great story telling, unless your writing something Neil Gaiman esque that plays on the realism. A lot of staring at houses for hours on end, pissing in bottles, that sorta thing.

I've had days where I start at 5 AM, and days where I don't get out till 2 AM. 80% of my time working is spent staring at someones front door waiting for

I have complete control over my schedule. I get cases in, and I organize them myself and decide when to work them. I generally have a lot of discretion when it comes to how files are worked, but sometimes there are specific instructions from clients. Some want specific with Pl's. If anyone ever tells you that, they are probably lying to you. If I intend on being hours, or specific days to cover different activities.

I deal with the police pretty often. I check in with them every day, as a professional courtesy, so that they don't have to waste time sending an officer out to check on me when they get suspicious vehicle reports. It works both ways, they can deal with calls on me directly over the phone, and they don't blow my cover by sending 3 cruisers to surround my vehicle. If I wanted to information people put online. I've had cases that would have failed completely had the person not put their new address, pictures of themselves, and even pictures of their vehicles (with license plates) online. Facebook's privacy settings are pretty solid, and there really isn't any legal way around them. If you hide all your pictures, there is no way that I can see them. One thing most people don't realize is how much information other people (who aren't so careful with privacy) post about you. I usually have a list of relatives and neighbors, and a good 50% of the time I can find pictures and info of whoever i'm following through someone elses profile, ie: parents, room mates, children, siblings.

Once you have a license you can buy a database search that provides you with every bit of information on anyone. Vehicles, addresses, phone numbers, relatives, nieghbors, social security numbers, birthdays, AKA's, even the square footage number of bedrooms and value of their house. It is all public information.

oddbrandon4: How does one acquire this license?

EIDochart13: just google your state's laws, they'll probably have everything you need on the site. Fill out paperwork, pay the fee, thats all.
